

LIMITED WARRANTY

HIGHLY LIMITED VALUE AND LIFE. Microgiant¹ warrants that (a) the SOFTWARE PRODUCT will perform substantially (defined with the requirement that the product not be installed for the first two months of operation) in accordance with the accompanying written materials for a period of ninety (90) days from the date of receipt, after which the product will self-destruct and you must spend an additional four hundred (400) dollars on purchasing another copy of the glitch-ridden product, and (b) any Support Services provided by Microgiant shall be substantially as described in applicable written materials provided to you by Microgiant, and Microgiant support engineers will make commercially reasonable efforts to solve any problem issues. The commercially reasonable clause entitles the Microgiant corporation to terminate any (all) technical support calls which pose a viable threat to its stockholders' well being and the maximization of its profit due to the cost of running any mode of technical assistance. If the end user is successful in locating the applicable written materials which cover Microgiant's technical obligations to the user, Microgiant corporation will deny the existence of such and promptly remove them from its servers. To the extent allowed by applicable law, implied warranties on the SOFTWARE PRODUCT, if any (Microgiant corporation sincerely hopes there are not), are limited to ninety (90) days.²

CUSTOMER CORRECTIVES (MICROGIANT'S DEMANDS). Microgiant's and its suppliers' entire liability and your exclusive remedy shall be, at Microgiant's option, either (a) return of the price paid, if any (requiring seven or more certificates showing authenticity of purchase after which the heretofore mentioned corporation will promptly terminate the end user's phone call at its convenience and change all its phone numbers to long distance, unstable foreign carriers prone to incessant static interruptions), or (b) repair or replacement of the SOFTWARE PRODUCT that does not meet Microgiant's Limited Warranty and which is returned to Microgiant with a copy of your original receipt (the corporation may be likely to challenge the authenticity of the copy and demand the original receipt, though it is not responsible for lost or misplaced end user property). This Limited Warranty is void if failure of the SOFTWARE PRODUCT has resulted from accident, abuse, or misapplication (resulted implies the possibility that the end user may not have committed the error; classification of many programming flaws and glitches may sometimes fall under accident or misapplication by inebriated programmers working under Microgiant's entity). Any replacement SOFTWARE PRODUCT will be warranted (against self-destruction) for the remainder of the original warranty period (as determined by Microgiant corporation) or thirty (30) days, whichever is shorter. Outside the United States, neither these remedies nor any product support services offered by Microgiant are available without proof of purchase from an authorized international source (id est, the end user must find the single recognized international source in all of Europe, located on the edge of the island of Elba, where Napoleon, Microgiant's international representative, was banished to after attempting to expand³ Microgiant's international presence throughout the remainder of the world.

THIS LIMITED WARRANTY GIVES YOU LIMITED LEGAL RIGHTS, IF THE END USER HAS NOT YET GAINED AWARENESS OF THIS AS OF THE PRESENT MOMENT. YOU MAY HAVE OTHERS, WHICH VARY FROM STATE/JURISDICTION TO STATE/JURISDICTION, BUT THE CORPORATION IS NOT OBLIGED TO PROVIDE ANY HELPFUL INFORMATION WHATSOEVER, SO IT WILL NOT.

LIMITATION OF LIABILITY. EXEMPLI GRATIA, IF THERE WERE A HYPOTHETICAL ATTACK ON YOUR COMPUTER NETWORK THAT SUCCEEDED DUE TO EVEN THE MOST EGREGIOUS SECURITY HOLE CAUSED BY THE QUALITY OF INSOBRIETY IN THIS ENTITY'S PROGRAMMERS AND ALL OF THE END ENTITY CUSTOMERS' CREDIT CARD NUMBERS WERE STOLEN AND THE END USER'S CORPORATION DESTROYED, MICROGIANT SHALL HAVE NO OBLIGATION.⁴ BY THE "FAILURE TO PROVIDE SUPPORT SERVICES" CLAUSE ABOVE, MICROGIANT IS RELIEVED OF ALL CALLS TERMINATED AT THE COMPANY'S COMMERCIALLY PRUDENT WILL THAT RESULT IN THE DESTRUCTION OF END USER'S ELECTRONIC EQUIPMENT. IN ANY CASE, MICROGIANT'S ENTIRE LIABILITY UNDER ANY PROVISION OF THIS CLAUSE SHALL BE LIMITED TO THE GREATER OF THE AMOUNT ACTUALLY PAID BY YOU FOR THE SOFTWARE PRODUCT OR U.S.\$1.00⁵ (FOR YOUR ENTIRE BUSINESS ENTERPRISE WORTH BILLIONS OF DOLLARS AND VAPORIZED IN MERE SECONDS); PROVIDED, HOWEVER, THAT IF YOU HAVE ENTERED INTO A MICROGIANT SUPPORT SERVICES AGREEMENT COSTING A SMALL SUM CONTAINING SEVEN (7) FIGURES, MICROGIANT'S ENTIRE LIABILITY REGARDING SUPPORT SERVICES IS INVALID AND THE END USER SHOULD SPEND SEVERAL ADDITIONAL DAYS READING THE LATEST LITIGATION BEING UNLOADED IN THE END USER'S BACKYARD BY FORKLIFTS. BECAUSE SOME STATES AND JURISDICTIONS (THAT HAVE AS OF YET NOT BEEN PURCHASED BY MICROGIANT CORPORATION) DO NOT ALLOW THE EXCLUSION OR LIMITATION OF LIABILITY, THE ABOVE MAY NOT (OR MAY DEPENDING ON MICROGIANT'S DISCRETION AND WHETHER OR NOT IT HAS PURCHASED YOUR SOUL) APPLY TO YOU.
