- Actively participate in at least one GSC committee or serve on the GRB

GRB representatives

- Attend panel hearings to review possible Honor Code violations
- Participate in other GRB meetings
- Help with Honor Code education, including presentations during New Student Orientation

Any graduate student currently enrolled at Caltech may serve as a GSC or GRB representative.

1. GSC or GRB option representatives need two (2) signatures from graduate students in their option. If the nomination form is submitted after the deadline, four (4) signatures are required.

2. GSC or GRB at-large representatives need ten (10) signatures from graduate students in at least four (4) different options. Late nominations require twelve (12) signatures from at least five (5) options.
